REPORT OF THE FOURTH TECHNICAL CONSULTATION MEETING ON INFORMATION COLLECTION FOR SUSTAINABLE PELAGIC FISHERIES IN THE SOUTH CHINA SEA 21 - 23 NOVEMBER 2005, JAKARTA, INDONESIA.

ADOPTED REPORT

I. INTRODUCTION

- 1. The fourth Technical Consultation Meeting on information Collection for Sustainable Pelagic Fisheries in the South China Sea was organized by SEAFDEC-MFRDMD and hosted by the Ministry of Marine Affairs and Fisheries, Indonesia, from 21 to 23 November 2005. For the realization of sustainable pelagic fisheries in the region, SEAFDEC has started a program "Information Collection for Sustainable Pelagic Fisheries in the South China Sea "funded by the Japanese Trust Fund II from 2002 to 2006 to clarify the current status of operation and catches of the purse seine fisheries. In addition the project aims to clarify the biological characteristics of pelagic fish resources caught by the purse seine fishery and to maximize the utilization of catches for pelagic fishes.
- 2. The Meeting was attended by the delegates from SEAFDEC Member Countries namely Brunei Darussalam, Indonesia, Malaysia, the Philippines, Thailand and Vietnam. The Meeting was also attended by two Resource Persons from Japan, representatives from SEAFDEC Secretariat, TD, MFRDMD, MFRD and observers from Indonesia, Malaysia, Myanmar and Thailand. The list of participants appears as **Annex 1**.
- The objectives of the Meeting were :
 - a) To discuss the progress and preliminary findings of the data collection and analyses by participating countries
 - b) To discuss the findings on the status of pelagic fisheries and the biological information of targeted species in the South China Sea
 - c) To discuss the achievements of maximizing utilization of pelagic fish
 - d) To formulate the format of national and regional report of the Trust Fun II Program
 - e) To formulate the work plan of activities for the years 2006

II. OPENING OF THE MEETING

- 4. Dr. Siri Ekmaharaj, the Secretary -General of SEAFDEC welcomed all the participants to the Meeting. He expressed his gratitude to Indonesia, particularly Dr. Made L. Nurjana, the SEAFDEC Council Director for Indonesia, for hosting this meeting. He then expressed his thanks to all the participants for attending the Meeting. His Welcome Address appears as **Annex 2**.
- 5. In his Opening Address, Dr. Made L. Nurjana, the SEAFDEC Council Director for Indonesia welcomed all the participants to Jakarta and hoped they would enjoy their stay in Jakarta. He stressed out this 3-day Meeting would discuss the strategies for the successful management of the pelagic fisheries in the South China Sea. Since various countries shared the resources of the South china Sea, the fisheries of this waterbody should be managed well as the sea has very diverse species of fish as well as the fishing methods. Dr. Nurjana fully supported the effort by SEAFDEC towards the successful management of pelagic fisheries in this region. He looked forward to the success of the Meeting and then declared the Meeting open. His Opening Address appears as Annex 3.

III ADOPTION OF AGENDA

6. The Agenda of the Meeting, which appears as Annex 4, was adopted.

IV RECOMMENDATIONS ON THE PROGRESS REPORT AND REGIONAL ANALYSIS

7. Based on the progress report of each country, as well as the report for regional analysis as appeared in Annex 5 through Annex 22, the followings were recommended:

A. Catch and Biological Data Collection

- a. The biological samplings and data analysis for all the participating countries would be continued until December 2005.
- b. The biological analysis would also follow the guidelines agreed during the Regional Technical Workshop held in Penang from 27 June to 1 July 2005.
- c. All countries should submit the national report to MFRDMD by 30 May 2006.
- d. MFRDMD would conduct a five-day group meeting tentatively in January or February 2006 to verify and analyze the raw data, examine together the results and give comments; and to refine the terminal report format. MFRDMD would sponsor one representative from each country and representative from TD. Additional participants should be funded by their own country or department.
- e. The final report format would follow the guidelines from the previous Regional Technical Workshop, which was held in Penang 2005. MFRDMD would refine the terminal report format and circulate to all countries before 1 January 2006.
- f. The final report would be made in two volumes:
 - i. Volume 1 (National analysis) to be published by 31 August 2006
 - ii. Volume 2 (Regional analysis) to be published by 31 December 2006
- h. The BBO devices should be returned to TD by January 2006. For the missing/unrecovered units, the Technical Officer of the participating countries should issue the official letter/report to TD.
- g. Based on the stock identification analysis, fishing ground determination and geographical features of the South China Sea, the Meeting agreed that the analysis for the national level would be done separately for each landing site except for Thailand, which would combine the data from all the landing sites; and Indonesia which would combine data for Pemangkat and Pekalongan.
- i. MFRDMD would compile the results from national output for the purpose of the regional analysis of the shared stock.
- j. The value of 'E' (exploitation rate) should be carefully interpreted.
- k. For the future data collection, the countries were advised to use the Catch and Biological Database Application developed by TD.
- After the completion of the projects, the member countries could publish the paper on their own using the data from this project by acknowledging SEAFDEC.
- m. The Regional Conference on Pelagic Fishery Resources and management would be held in September 2006.

B. Maximizing Utilization of Pelagic fish Resources

- a. The economic aspect such as cost-return analysis should be made to each of the product by the countries, if they have sufficient data.
- b. The format of the processing manual would follow the previous publication on "Maximizing Utilization of Fish Catch Marine Species".
- c. The participating countries should submit the draft of processing manual on their products to MFRD by February 2006.
- d. MFRD would edit and print the processing manuals, which also include costing, photographs, materials/ingredients and nutritional composition of the products (if available), and distribute them during the End-of-Activity Seminar in August 2006.
- e. The End-of-Activity Seminar would invite the participants from all SEAFDEC member countries.

V. WORK PLAN 2006

- 8. The Meeting had agreed with the following envisaged outcomes for 2006:
 - i. Publication on overall national and regional analysis of fishing operation, catch and biological data
 - ii. Publication on regional analysis on stock identification of selected pelagic fishes through morphometric statistical analysis and DNA analysis.
 - iii. Publication on oceanographic parameters (SST, Ocean color, etc.) in relation to pelagic fish distribution.
 - iv. Publication on processing manual for maximizing utilization of pelagic fish resources.
 - v. Conducting End-of-Activity Seminar on maximizing utilization of pelagic fish resources.
 - vi. Conducting a regional conference on pelagic fish resources and management.

This program is focusing on the purse seine fishery which also the major fishing gear to exploit pelagic fish in this region. Two major species groups namely mackerels and roundscads have been identified for study in detail. Their status of exploitation and utilization would be useful information in formulating proper sustainable management for these species in the region.

Ladies and gentlemen

The information obtained during this program and data compiled by all participating countries will hopefully not end in 2006 when this regional program terminates. The activities can be continued by respective participating countries and good quality data and information can be obtained towards the formulation of sustainable development and management of the resources at each national level.

Considering the current financial situation of SEAFDEC, each department needs to review their program for the best use of fund available and probably needs to implement certain drastic measure to ensure SEAFDEC sustainability after 2006.


